



SPECIFIC AGREEMENT OF STUDENT EXCHANGE
between
STATE UNIVERSITY OF NEW YORK AT STONY BROOK
and
UNIVERSIDAD DEL PACIFICO

In accordance with Section II of the Memorandum of Understanding between the State University of New York at Stony Brook, hereinafter SBU, and, Universidad del Pacifico, Lima, Peru, hereinafter UP, the following mechanisms designed to encourage and facilitate the exchange of undergraduate students are hereby established:

1. Students could participate in the exchange program for one full academic year or for one semester.
2. The number of students to be exchanged each year shall be determined according to the demand of the students; the parties shall coordinate and express their consent no later than February 1 of the preceding academic year. SBU and UP agree to achieve for full reciprocity for the student exchange within three years. This balance may be achieved by an exchange of an equal number of students or other academic exchanges.
3. Study Abroad Conditions
 - I) In the event that there is an imbalance in the number of students wishing to exchange, the parties may send or receive more exchange students, as long as the Host University allows it.
 - II) Students enrolled in such a Study Abroad program will be subject to all of the exchange conditions listed within this Appendix with the exception of tuition waivers.
 - III) Payment of fees for Study Abroad students undertaking studies at the host institution will be in accordance with the fee collection procedures of the host institution.
4. Initial selection of students will take place at the home institution; however, the host institution reserves the right to deny admission to any student not meeting its general admission criteria.
5. Student dossiers should be received at the host institution no later than March 15 for fall admissions and October 15 for spring admissions.



6. Each host university shall assist incoming students about information of accommodation. Students shall be responsible for their own housing and meal costs.
7. Admitted students shall be responsible for tuition, orientation, housing and meal costs. Where reciprocity exists, the host university shall waive tuition costs for incoming students.
8. Students shall be required to enroll in the mandatory health insurance program and shall be responsible for all deductible costs related to health care services.
9. Students must be enrolled in a full-time course load at the host university for the duration of the program and in accordance with the student's degree program.
10. Students shall be free to choose courses from the full range of courses available at the host university, provided they satisfy course prerequisites and if required, departmental consent.
11. Students shall comply with all rules and regulations of the host university, including relevant academic standing and conduct requirements.
12. Students who participate in the exchange program will not be degree candidates at the host university.
13. On the request of the student, at the end of a student's program overseas, the host university shall send to the home institution an official record of coursework completed at the host university.
14. Each university shall assess the academic work completed at the other university and shall award credit to its students in accordance with its own academic policies and regulations. Neither university shall be liable for the acts of the other or for the acts of students participating in this exchange.
15. The host university shall inform prospective exchange students of the requirements for entry to the other country, but arrangements for passports, visas, and other entry requirements are entirely the responsibility of the individual students.

To comply with host country regulations, exchange students shall be required to provide a guarantee that they have financial resources sufficient to meet all expenses.



16. This Agreement shall be in effect for the same period as the Memorandum of Understanding and may be adjusted in writing upon mutual agreement of the two parties. For matters not covered in Agreement, the universities shall consult their Memorandum of Understanding.
