STUDENT EXCHANGE APPENDIX
to the
MEMORANDUM OF UNDERSTANDING
between
STATE UNIVERSITY OF NEW YORK AT STONY BROOK
and
TOHOKU UNIVERSITY

In accordance with Section II of the Memorandum of Understanding between the State University of New York at Stony Brook, hereinafter SBU, and Tohoku University, hereinafter TOHOKU, the following mechanisms designed to encourage and facilitate the exchange of undergraduate students are hereby established:

1. Students are to be exchanged for one full academic year or for one semester.
2. Each university will have no more than 3 students from the other side enrolled at any time. The number of students to be exchanged each year shall be determined by mutual consent no later than February 1st of the preceding academic year. SBU and TOHOKU agree to achieve for full reciprocity for the student exchange within three years. This balance may be achieved by an exchange of an equal number of students or other academic exchanges.
3. Study Abroad Conditions
 - I) In the event that there is an imbalance in the number of students wishing to exchange, the parties may agree to establish a Study Abroad program additional to the above student exchange program for students from the home university to study at the host university.
 - II) Students enrolled in such a Study Abroad program will be subject to all of the exchange conditions listed within this Appendix with the exception of tuition waivers.
 - III) Payment of fees for Study Abroad students undertaking studies at the host university will be in accordance with the fee collection procedures of the host university.
4. Initial selection of students will take place at the home university; however, the host university reserves the right to deny admission to any student not meeting its general admission criteria.
5. The host university will determine the required language skills for admission in each case,

in order to assure that the student has the minimum requirements to carry out his/her studies successfully.

6. Student applications should be received at the host university no later than the deadline specified by each university.
7. The host university will be responsible for assisting students to find adequate accommodation on or near the host campus. The host university will be exempt from this responsibility if the student declines the recommended accommodation. On-campus accommodation is given subject to availability but is not guaranteed.
8. Admitted students shall be responsible for tuition, orientation, housing and meal costs. Where reciprocity exists, the host university shall waive application, matriculation, and tuition costs for incoming students.
9. Students shall be required to enroll in the mandatory health insurance program of the host university and shall be responsible for all deductible costs related to health care services.
10. The host university will not be liable for travel, living, healthcare, insurance or other expenses incurred by the students.
11. Students must be enrolled in a full-time course load at the host university for the duration of the program and the course must be in accordance with the students' degree program at their home university.
12. Students shall be free to choose courses from the full range of courses available at the host university, provided they satisfy course prerequisites and if required, departmental consent.
13. Students shall comply with all rules and regulations of the host university, including relevant academic standing and conduct requirements.
14. Students who participate in the exchange program will not be degree candidates at the host university.
15. On the request of the student, at the end of a student's program overseas, the host university shall send to the home university an official record of coursework completed at the host university.
16. Each university shall assess the academic work completed at the other university and shall award credit to its students in accordance with its own academic policies and regulations. Neither university shall be liable for the acts of the other or for the acts of


students participating in this exchange.

17. The host university shall assist incoming students to obtain visas and other documents required for entry to the host country. To comply with host country regulations, exchange students shall be required to provide a guarantee that they have financial resources sufficient to meet all expenses.
18. Each university will appoint a contact office and/or person to facilitate the implementation of the program. The appointed offices or persons will act as contact for enquiries about the program and will also be responsible for promoting, advertising and overseeing the smooth operation of the program.
19. This Appendix shall be in effect for the same period as the Memorandum of Understanding and may be adjusted in writing upon mutual agreement of the two parties. For matters not covered in Appendix, the universities shall consult their Memorandum of Understanding.
