



ADDENDUM FOR STUDY ABROAD PROGRAM
to the
AGREEMENT OF COOPERATION
between
THE STATE UNIVERSITY OF NEW YORK AT STONY BROOK
and
EWHA WOMANS UNIVERSITY

The State University of New York at Stony Brook, the United States of America ("SUNYSB") and Ewha Womans University, the Republic of Korea ("EWU") hereby enter into this Amendment to the Agreement for the program titled "Ewha in New York at Stony Brook University." This Amendment supplements the Agreement between SUNYSB and EWU dated July 18, 2005 (the "Original Agreement"). Both parties agree to the following mechanisms designed to enhance educational experiences and cultural understanding of the involved students.

It is agreed that:

1. **Number of Visiting Students**
Each year, during the term of the agreement, EWU may send up to 100 full time undergraduate and/or graduate students to SUNYSB. Standard length of stay will be one semester or a full academic year. Semester or academic year shall normally refer to the period relevant to the SUNYSB.
2. **Recruitment**
SUNYSB agrees to provide EWU with an adequate and timely supply of printed material concerning the program of instruction. EWU agrees to screen all prospective students with information supplied by SUNYSB to ensure that they have adequate English language skills to perform college level work, and that they have a serious intention to study.
3. **Tuition and Administration Fee**
Students are to attend SUNYSB on a full fee-paying basis. EWU students will be charged Stony Brook tuition at the normal rate otherwise applicable to out-of state residents, discounted by ten (10) percent. Charges for tuition, as discounted, and applicable student fees for international students, and all other regular, mandated fees

will be made to each Ewha student individually, but be paid collectively by Ewha's Office of Global Affairs. Payment of such tuition and fees shall be made in accordance with standard policies of Stony Brook University. Charges for special classes, courses, and other goods, services, and activities not otherwise levied on regularly enrolled Stony Brook students shall be billed directly to Ewha students in accordance with standard policies and procedures of Stony Brook University, which alone shall be responsible for their collection.

4. Accommodation and Expenses

SUNYSB shall guarantee on-campus housing for the visiting students at the West Apartments or other housing of similar condition. The payment of housing costs and payment for all travel, medical insurance and subsistence costs shall be the responsibility of the visiting student and EWU will not be responsible for such charges. The Ewha students will be billed for such housing and board plans at the same rate charged regularly enrolled Stony Brook students, and will be solely responsible for paying such charges in accordance with Stony Brook's standard policies and procedures.

5. Travel and Visa

Each visiting student is responsible for travel arrangements and visa. SUNYSB shall provide the students with any university certification needed to obtain a student visa for the full period of study.

6. Selection of Visiting Students

Students will be selected by EWU on the basis of:

- i. Academic excellence
- ii. Seriousness of interest in the study proposed
- iii. Adequate language competence. Students applying for the program should have for TOEFL examinations a minimum score of 550 on PBT, a minimum of 213 on CBT, or a minimum of 80 on IBT. For IELTS, a score of 6.5 or higher is required. For students who are academically admissible to SUNYSB, but with English language skills below the above mentioned language requirements, applicants may be eligible for admission through language session at the Intensive English Center at SUNYSB.
- iv. Capacity to adjust to cross-cultural situations.

7. Admittance

Each student selected for participating in this program will be admitted as a non-degree student to SUNYSB upon submission of:

- i. An application for admission
- ii. An official college transcript
- iii. A recommendation letter by the faculty or advisor
- iv. Health record statement

It is understood that students admitted under the terms of this Agreement will continue as candidates for degrees at EWU, and will not be candidates for degrees of SUNYSB.

8. Courses Registration

Visiting students may take courses offered during the regular semester or during the summer semester open at SUNYSB.

9. **Credits**
Academic credits earned in courses taken by the visiting student while studying at SUNYYSB may be accepted by EWU, provided that such is judged as appropriate by the latter. At the end of the term of study, SUNYYSB will provide EWU with a final official transcript of the grades obtained by each visiting student.

10. **Rules and Regulations**
Visiting students shall be subject to the rules and regulations of SUNYYSB and the country. They will also have the rights and privileges enjoyed by all students of SUNYYSB.

11. **Insurance**
Visiting students will be required to be covered by health insurance as mandated by the regulations of SUNYYSB.

12. **Liaison and Administrative Office**
This program will be coordinated by International Academic Programs at SUNYYSB and the Office of Global Affairs at EWU.

SUNYYSB agrees to designate a mentor who would be responsible for giving appropriate support and care to the EWU visiting students on SUNYYSB campus.

Upon agreement, official office space will be provided at the SUNYYSB campus under the name of "Ewha in New York Office." EWU agrees to recruit and send an appropriate faculty or staff member in the assistance for the visiting students under "Ewha in New York" program. SUNYYSB will provide general administrative support, phone line, Internet access, necessary office equipments and other maintenance services for the office.

13. **Approval and Duration**
This agreement will be effective as of its date of signature by the representatives of both institutions. The agreement is subject to revision, renewal and cancellation by mutual consent at least six months in advance in writing given by either university to the other.

The undersigned agree to these Bylaws on behalf of their respective institutions.
