

APPENDIX

AGREEMENT OF COOPERATION

A PROGRAM OF STUDY AT STONY BROOK UNIVERSITY
by students from
XI'AN JIAOTONG UNIVERSITY

In accordance with Section II of the Agreement of Cooperation between the State University of New York at Stony Brook ("Stony Brook" or "Stony Brook University") and Xi'an Jiaotong University, this Appendix is added to establish the terms under which students from the undergraduate schools of Xi'an Jiaotong University may enroll in Stony Brook University for up to a year of individualized study.

1. Students from Xi'an Jiaotong University may enroll at Stony Brook University for periods of study not to exceed one academic year during the life of the Agreement of Cooperation between Xi'an Jiaotong University and Stony Brook University, subject to the provisions which follow.
2. No more than twenty (20) undergraduates from Xi'an Jiaotong University may be in the study abroad at Stony Brook at any given time, except as may be agreed to mutually by the respective universities.
3. Students will be selected to participate in this program by Xi'an Jiaotong University in accordance with principles and practices of the faculties of its undergraduate schools. However, Stony Brook reserves the right to deny admission to any student not meeting general admissions criteria.
4. Student dossiers should be received at the host institution no later than March 15 for fall admissions and October 15 for spring admissions.
5. Xi'an Jiaotong University students will be free to choose courses from the full range of courses available to undergraduates at Stony Brook excluding areas of health sciences, provided they satisfy course prerequisites and space in the selected course is available. Stony Brook University's Department of Physics and Astronomy will provide research training opportunities to selected Xi'an Jiaotong University students.
6. Charges for tuition, applicable student fees for international students, and all other regular, mandated fees will be made out to each Xi'an Jiaotong University student individually. Payment of such tuition and fees shall be made in accordance with standard policies of Stony Brook University.
7. Stony Brook will provide incoming Xi'an Jiaotong University students with on-campus housing in residence halls otherwise used by regularly enrolled Stony Brook students. Xi'an Jiaotong University students will be billed for such housing and board plans at the same rate charged regularly enrolled Stony Brook students, and will be solely responsible for paying such charges in accordance with Stony Brook's standard policies and procedures.


8. Xi'an Jiaotong University students must be enrolled in a full-time course of studies at Stony Brook for the duration of the program and in accordance with Xi'an Jiaotong University policies regarding normal progression toward their degree. Xi'an Jiaotong University students participating in the semester or academic year of study at Stony Brook will not be degree candidates at Stony Brook University.
9. On the request of the student, at the end of a student's program overseas, Stony Brook University shall send Xi'an Jiaotong University an official record of coursework completed at the host university.
10. Stony Brook will help admitted Xi'an Jiaotong University students to obtain visas and other documents required by current U.S. entry and visa requirements. Admitted students remain responsible, at all times, for maintaining appropriate immigration status. Xi'an Jiaotong University students will also be required to enroll in the mandatory insurance program of the State University of New York, and shall comply with Stony Brook's academic standing and conduct requirements. Neither Xi'an Jiaotong University nor Stony Brook University shall be responsible for the acts of the other, or for the acts of any student participating in this program.
11. This Appendix shall be in effect for the same period as the Agreement of Cooperation and may be adjusted in writing upon mutual agreement of the two parties. For matters not covered in Appendix, the universities shall consult their Agreement of Cooperation.


